**Rules and Regulations:**

- Each contestant must be a resident of Rhea County. Verification is required with application: please include a copy of driver's license or submit a letter from current attending school which shows the contestant's address.
- Contestant cannot qualify if she has ever been married, had a child or convicted of a felony.
- Fairest of the Fair (ages 16-20) must have reached her 16<sup>th</sup> birthday, but not her 21<sup>st</sup> birthday on or before December 31<sup>st</sup> of the year of the contest.
- Costumes must be formal and must be floor length. No exposed midriff. Contestants will not be allowed to carry flowers during the judging.
- Contestants will be judged on beauty, poise and personality.
- Judges decisions are final. Please refrain from contacting them before, during or after the pageant.
- The Fairest of the Fair and Junior Fairest of the Fair must participate in all Rhea County Fair Events and represent Rhea County Fair during the entire year of her reign. If she does not participate or represent the Fair she will be asked to resign from her reign and the 1<sup>st</sup> runner up will attain the crown.
- The contestant must be of the female gender.
- The winner will receive a trip to Nashville to participate in the State's Fairest of the Fair Contest with all expenses paid.
