****Selection Criteria***

The Rhea County Fair strives to provide its guests with the most variety, uniqueness and value throughout our Fair. Our Food Vendor selections reflect this goal as well. We also give much consideration to factors that will maximize your potential for profits including limiting the number of vendors selling like products, matching your price points to our guests.

****Menu Choices***

On your application, please fill out your top three menu choices. Please choose unique items that chance less chance for duplication. We will do our best to give selected vendors their first choice, but cannot guarantee they will receive it. We do not want duplications of product at the Fair since it is not in the vendors best interests for profit and not in the guests' best interest for the variety. Once the Fair has approved the items you wish to serve, there will be no substitutes or changes in products. Changes or substitutes will void the vendor agreement with the Rhea County Fair and violations will result in dismissal from the Fair as well as forfeiture of all Food Vendor fees.

Hamburgers, Hotdogs, and breakfast items will be excluded from your menu. These items will be served from the concession stand on the fair site.

Only Coke Products will be available at the Fair site. However, specialty food vendors will not be allowed to sell Coke Products. The drinks available to be sold by the Specialty Food Vendors are: Lemonade, Tea, Coffee, Kool-Aid, Bottle Water and Specialty drinks.

There will be Ice available for purchase by all food vendors and the Food Chairmen (Bill and Brenda Thedford) will manage it.

The Food Vendors presence is require the entire length of the Fair. Food Vendors must be set up and ready for business at the designated opening time and must remain open until the designated closing time. There will be no closing earlier or early sell outs at discounted prices.

Admission Gate will be opening daily at 4 PM and closing at 9 PM, exceptions are on Saturday 9-4 and 9-11, Gate will be open from 8 AM to 9 PM; and Monday 9-6-09 gate will be open from 8 AM to 9PM.

The undersigned hereby releases and agrees to indemnify and hold harmless Rhea County and Rhea County Fair Association, its employees, its volunteers, agents and assigns for the same regarding any and all liability for damages or injuries to persons or property which the undersigned, his or her agents or employees or volunteers may sustain while participating at the Rhea County Fair or any event leading up to the Fair or related to the Fair.

I have read the application rules and agree to abide to the rules or regulations of the Fair as set forth and herein and to be subject to the penalties provided for failure to comply. I understand that the Rhea County Fair and Rhea County reserves all rights to refuse participation based on Event rules and guidelines. If these guidelines are not upheld and if I fail to comply timely with any of these rules or regulations I may be barred from participating in the Rhea County Fair for both this year and future years and that I may be subject to fines or penalties set forth in this document. I also hereby consent and authorize the Rhea County Fair to use film, video, sound recording, and/or photography and written or verbal information supplied by me for the purpose of publicity and/or promotion and/or advertising. No claim of any nature arising out of, or connected with, said photography, publicity, promotion or advertising will be made by me, my survivors, or assigns.

I understand that all promotion of items must take place within the confines of my booth. I further understand that there are no refunds or rain checks.

I have read and agree to all the regulations states above and in consideration of applying for the Rhea County Fair agree to be contractually bound to the same.

I understand that if litigation is necessary to enforce the terms of this contract that the Rhea County Fair shall be entitled to recover from me the reasonable attorney's fees and litigation cost.

A new rule set for all the Fair Grounds will be No Soliciting of Money by anyone or any vendor. Meaning no vendor or individual may give out samples of any product and ask for a donation.

You will be responsible for all fees for health inspections and licenses.

Rhea County Fair Food Vendor Fee is \$125.00 and is due on August 10th. Please do not send application fee with this application.
